THE MISS AMERICA SCHOLARSHIP FUND THROUGH THE MISS SEVEN RIVERS ORGANIZATION OF
WISCONSIN WILL AWARD SCHOLARSHIPS UNDER THE FOLLOWING CIRCUMSTANCES:

1) ALL SCHEDULED APPEARANCES ARE ATTENDED BY MISS SEVEN RIVERS OUTSTANDING TEEN 2011:

- a.) Miss Seven Rivers Outstanding Teen 2011 will attend all appearances scheduled by the Miss Seven Rivers Organization. All appearances will be schedule prior to July 1, 2011. Other appearances made by Miss Seven Rivers Outstanding Teen 2011 must be approved by the Director.
- b.) Miss Seven Rivers Outstanding Teen 2011 will write Thank You notes to all specified sponsors. She will be provided with postage for said sponsor letters. Other postage will be paid by Miss Seven Rivers Outstanding Teen. She will receive 100 official Miss Seven Rivers Outstanding Teen stationery with envelopes. Any additional stationery must be requested through the Director.
- c.) Miss Seven Rivers Outstanding Teen 2011 will attend the Social Sendoff for Miss Wisconsin Outstanding Teen 2011 (to be attended by Miss Seven Rivers Organization Sponsors, family, and friends).
- d.) Miss Seven Rivers Outstanding Teen 2011 will be given the option to attend the Miss Wisconsin Preview Night where she will watch Western Wisconsin titleholders (typically a Wednesday in early June).
- e.) Miss Seven Rivers Outstanding Teen 2011 will attend all scheduled appearances and competitions for Miss Wisconsin Outstanding Teen Prep Day (a Saturday in May) and Miss Wisconsin Outstanding Teen 2011 (4-5 days in June).
- f.) Miss Seven Rivers Outstanding Teen 2011 will attend and fulfill obligations at the Miss Seven Rivers Pageant 2012.
- g.) Consent is given for personal and professional photographs including contestants, the Miss Seven Rivers Pageant, and/or Miss Seven Rivers Outstanding Teen 2011 to appear on the Miss Seven Rivers website and other publications.

2) ALL OTHER RULES ARE FULFILLED:

- a.) Wardrobe for the 2011 Miss Wisconsin Outstanding Teen Pageant must be approved by the Miss Seven Rivers Organization no later than June 1, 2011.
- b.) Official Miss America Outstanding Teen Local crown must be returned to the Miss Seven Rivers Organization no later than January 1, 2012. If the crown is not returned by said date, the Miss Seven Rivers Organization reserves the right to charge a \$120 crown fee to titleholder. Please consult with the Miss Seven Rivers Organization if the crown would like to be purchased for personal usage.

c.) Official Miss America Outstanding Teen Local sash must be returned to the Miss Seven Rivers Organization no later than January 1, 2012. If the sash is not returned by said date, the Miss Seven Rivers Organization reserves the right to charge a \$50 sash fee to titleholder. Please consult with the Miss Seven Rivers Organization if the sash would like to be purchased for personal usage.

d.) All scholarship money will be presented at the Social Sendoff for Miss Seven Rivers Outstanding Teen 2011.

3) SCHOLARSHIP USAGE:

Scholarship money awarded should be used toward future educational opportunities.
